Our structure is a non-profit organization which reached the **state-approved body since 2004**. And our mission is to verify the compliance of the electrical installations with the safety standards in effect. We endorse the Certificates of conformity filled in by the person who carried out the work.

The DGEC* supervises our action and fixes the price list concerning our services. Our Board of Directors consists of three categories of members representing the different actors of the electrical sector:



CONSUEL has built a **strong partnership with electrical contractors** through the organization of technical meetings, through the communication of technical information and the help provided for the monitoring of regulatory evolutions. To make their daily life easier, we adapted new technologies in our process and developed efficient online services such as the complete dematerialization of our endorsement process concerning the certificates of conformity.

Since 1998, CONSUEL is an **accredited** inspection body by the COFRAC** according the NF EN ISO/CEI 17020 standard. This official recognition is the evidence of our proficiency and impartiality.

Thanks to the experience and the professional quality of the team, CONSUEL is now recognized as an expert and a **technical advisor** by both the electrical sector and the public authorities. We take part in many working groups on electrical safety including the DHUP, the Ministry of Labor, AFNOR, PROMOTELEC and other organizations.
